Board Chair Rebecca Elder called to order the RBTT Board of Directors Meeting at 9:31am.

II. Approval of Minutes

Review and approve the Meeting Minutes. Rebecca Elder made a motion to approve & file minutes, Kasi Iacono seconded. A vote was held, no opposed and the motion passed.

Review and approve Financials provided by Kasi Iacono, Treasurer. Melissa Alvarez made a motion to approve, Justin Jaramillo seconded. A vote was held, no opposed and the motion passed.

Suggestion to also include some North Redondo activities such as The Great Room and tennis courts at Anderson park. Rebecca Elder made a motion to approve a spend not to exceed \$8K for April & May for the Influencer Partnership. Kasi Iacono seconded, a vote was held, no opposed and the motion passed.

 - ii. PSM is preparing creative for the eventual transition away from covid messaging as restrictions lif.t
 - iii. 38% of 3rd night free funds have been allocated. Discussion of extending, some hotels have exhausted budget by funding remains. Kasi Iacono & Rebecca Elder

shared that they would like to keep the promotion going through the end of April. Justin Jaramillo shared that the campus hotels have not seen any traction on the third night offer due to the mix of business to the property, but they supported the extension. Rebecca Elder made a motion to approve extending the third night free into April, Rachael Prochnow seconded. A vote was held, no opposed and the motion carried.
